Purpose of the Report

Quarterly updates of the Dialysis Facility Report (DFRs) are utilized by each state's surveying agency as a resource during the survey and certification process. This report provides more recent results of select measures from the Fiscal Year (FY) 2020 DFR.

The two most recent calendar year results from the FY 2020 DFR are provided along with quarterly updates. Summaries include chronic dialysis patients who were treated in this facility between January 2017 and March 2019. Regional and national averages for the most recent year reported in the FY 2020 DFR are included to allow for comparisons. Quarterly updates of the non-italicized outcomes for 2019 will be provided to State Surveyors in December 2019 (Q1), March 2020 (Q2), and June 2020 (Q3). Italicized outcomes are updated annually in September. Unless otherwise specified, data refer to combined results for hemodialysis (HD) and peritoneal dialysis (PD) patients and summaries are for the calendar years reported in the table header. Missing values indicate there were too few patients to yield reliable results.

This report has been prepared by the University of Michigan Kidney Epidemiology and Cost Center (UM-KECC) with funding from the Centers for Medicare & Medicaid Services (CMS) and is based primarily on data reported in CROWNWeb, Medicare claims and data collected for CMS. The age-adjusted waitlist percentage is not shown if there are fewer than 11 eligible patients.
